Approve Meeting Minutes - April 5, 2024

Chair Andy Bishop asked for a motion to approve the April 5, 2024, meeting minutes as emailed. <u>Tammy Wiedenbeck moved</u>, and <u>Jason Hitch seconded to approve the minutes as emailed</u>. <u>Motion passed</u>.

Amended Authorization Request

Char Andy Bishop and Greg Hanes, CBB, noted the amended authorization No-Cost Amendment FMPRE request to AR #2210-R and asked for discussion. Discussion.

<u>Dave Hamilton moved, and Jason Hitch seconded to approve the AR #2210-R, FMPRE as</u> amended. Motion passed.

Revenue Projection Update for FY 2024

Chair Andy Bishop called on CBB Director of Collections Compliance, Chad Smith, to review projected revenues for FY 2024. Mr. Smith reviewed the updated projected FY 2024 Assessment Revenue based on amounts collected through April 30, 2024, CBB anticipates that actual FY 2024 revenue will exceed budget revenue projections. Any excess funds received through the end of the fiscal year will be added to CBB's available funds balance and will be available to the AR program budget in future years.

CBB CFO, Jeff Lutz, discussed the process in which additional available funds are handled and communicated with both the Beef Promotion Operating Committee (BPOC) and CBB Executive Committee ahead of the September funding meeting. This is the meeting where the final available funds within the program budget are released for the BPOC to fund Authorization Requests (AR) within the Program budget. Once the Program budget is approved the final budget is sent to the Cattlemen's Beef Board to approve via electronic ballot, then USDA ahead of the start of the fiscal year starting October 1.

FY 2025 Proposed Program Budget

CBB Budget & Audit Committee, Chair Seth Denbow provided a report on the FY 2025 preliminary program budget. Mr. Denbow reported the Budget & Audit Committee met on May 10th and approved the FY 2025 Budget. The Committee recommended a total budget of \$40,517,200 for FY 2025. The total recommended Program Budget of \$37,496,340 is comprised of the following budget categories: total Authorization Request (AR) budget of \$36,241,340, Evaluation budget of \$305,000, Program Development budget of \$750,000, and Checkoff Communications Resource budget of \$200,000.

<u>John Ferry moved, and Ryan Moorhouse seconded to recommend the FY 2025 proposed</u> preliminary budget to the Executive Committee. Motion passed.
