CEO Greg Hanes gave an update on the following:

- Greg recognized & thanked CBB staff for pulling this August meeting together as well as the work they are
  doing in preparation for the meetings in September.
- AR books are in progress and will be shipped no later than August 14<sup>th</sup>.
- We have received more FOIA's from "Our Honor Group" and are working with USDA on those requests.
- Aimpoint Future of Agricultural Checkoffs preliminary report is completed and will be forwarded to the Executive Committee.
- ROI Study has had a lot of positive feedback, including 17 articles and 30 postings. Our team has received 7,000 requests for copies of the ROI brochure.
- Davis Gidney, CBB Checkoff Education Manager has received over 6,000 orders for the Shared Youth marketing materials.
- We have over 700 users in the Knowledge Center with a 100 of those being organic from site visitors.
- Jeff Lutz is working on finalizing the budget ahead of the meetings in September. He will share the additional funding for ARs in the next couple of weeks.
- AR Insights Webinars have been weekly and will go through the end of August. EC members are encouraged and welcome to attend.
- HPAI has had a big impact on dairies and in human health within the state of Colorado.
